RELEASE AND ASSUMPTION OF RISK AGREEMENT

The undersigned participant understands and acknowledges that Georgia Wilderness Society, Inc. and its officers, agents, and trip leaders (hereafter "GWS") are not responsible for providing any supplies or services for the activity listed below, including leadership safety, medical rescue, maps, directions, shelter, weather protection, training or instruction. Participant has made his or her own determination of the risks involved in the activity, and has not relied upon any advice or announcements by GWS regarding such risks. The undersigned assumes all risks of injury or contagion to person or loss or damage to property from the activity and from other participants. During the activity members may be so spread out that a lost, injured, or endangered member may not be located, assisted or rescued by GWS. GWS has not provided any leadership, first aid, or rescue training to its trip leaders. Any guidelines or suggestions provided to trip leaders are for their information only and do not create any responsibility on the trip leader to conduct the activity for the participants' benefit or safety. The undersigned further assumes all risk of contagion of COVID-19 and other diseases or infections from others, including participants, and also from water born/environmental diseases or infections, and acknowledges that shuttles, hikes, and other activities cannot or may not be conducted to comply with social distancing recommendations.

In consideration of the privilege of being allowed to participate in the following described activities, the undersigned or signer of attached GWS trip list hereby releases and relinquishes any and all claims same may have for any injuries or contagion that he/she sustains while either in route to or from said activities or during the course of said activity, regardless of the cause of said injuries and regardless of the nature, either personal injury or property damage, and the undersigned or signer of attached GWS trip list completely discharges and agrees to hold harmless the members, officers, directors, and all others affiliated with the Georgia Wilderness Society, Inc. This release is intended to specifically encompass any and all injuries resulting from any cause whatsoever, including but not limited to, accidents, contagion, theft of personal property by other persons or loss of same, injuries or property loss from fire, drowning, falling, altercations with other persons, and attacks by animals.

The undersigned or signer of attached GWS trip list acknowledges and accepts exclusive liability for the risks of any and all injuries, damages, or other misfortunes which may result from any activity consisting of backpacking, hiking, canoeing, biking, or any other form of meeting and/or transportation to and from the appointed destination and all other injuries and property losses which may be incidental to such activities.

The undersigned or signer of attached GWS trip list acknowledges his/her sole responsibility for medication and/or equipment required for said person to be self-sufficient, including specifically any medications related to his/her health condition, or allergies.
